AAPL Code of Ethics

- **Section 1**

- Establish and maintain goodwill between the industry and the public.
- Be fair and honest.

AAPL Code of Ethics

- **Section 2**

- Compete, but with honesty and courtesy.
- Do not use confidential information for personal gain.
- No conflicting interest with employer or client.
- Act in good faith.
- Do not represent to be skilled in professional areas in which not qualified.

 - Unauthorized use of CPL, RPL, RL, P.Land, and CPL/ESA.

 - Communications Concerning a Lawyer's Services.
- **Rule 7.04**
 - Advertisements in the Public Media.

- **Standard 3**
 - Promote employer interests.
 - Fairly treat all parties.

State Bar Rule 5.08

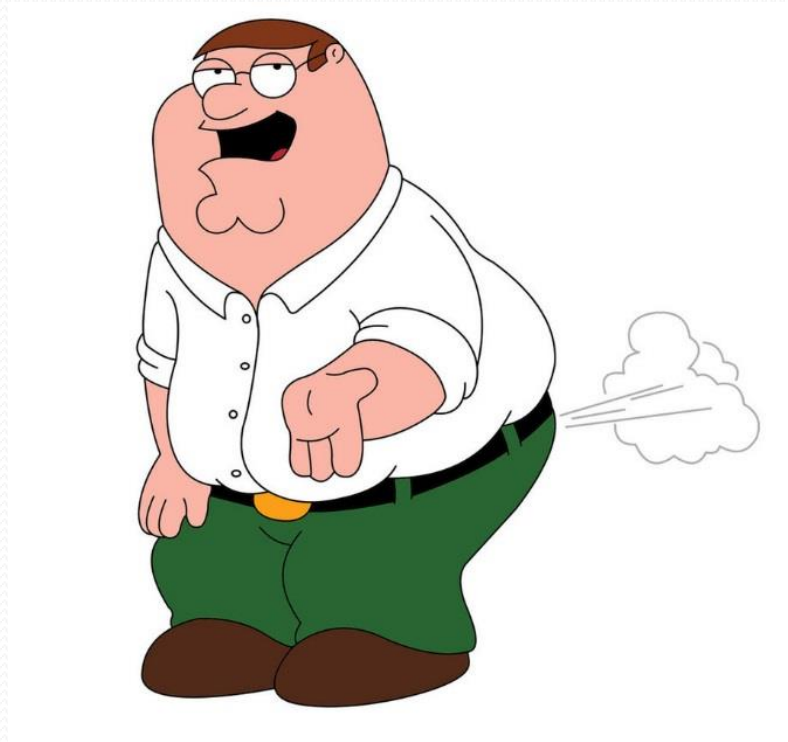
- **Rule 5.08**
