The tournament problem was released by email yesterday and will be posted to the website tomorrow.

I need to clarify one thing regarding the trial brief assignment. I initially told you to write a trial brief for the defendant after the plaintiff filed a motion in limine to exclude certain statements the defendant wants to use. But of course, I got the parties' designations backwards. Here is what it should be: write a trial brief for the Plaintiffs (Cameron Tucker and Mitchell Pritchett) after Defendant (Claire Dunphy) filed a motion in limine to exclude certain statements the Plaintiffs (Cameron Tucker and Mitchell Pritchett) want to use. The specific exhibits at issue are Exhibit I (liked by Claire), Exhibit J (shared to Claire's page, liked by her and not deleted), and Exhibit K (shared to Claire's page but not liked or deleted by her). Everything else about the trial brief assignment remains the same.

In light of my mix-up, the deadline will be extended. The trial briefs are now due Monday, March 5th (instead of March 1st). Trial brief numbers were distributed by email earlier today. Please refer to the local rules for the specific requirements related to the preparation and submission of the trial brief.

I have attached the official ballots that will be used during the tournament.

The role of Cameron Tucker must be played by a male. The role of Claire Dunphy must be played by a female. The roles of Charlie Bingham and Leslie Collins may be played by either males or females. Each team will be assigned one South Texas student, who will play two witness roles during the tournament. Teams may choose one of the following options:

- (1) to have your South Texas witness play the roles of Charlie Bingham (plaintiffs' expert) and Leslie Collins (defendant's expert) while team members play the roles of Cameron Tucker (plaintiff) and Claire Dunphy (defendant).
- (2) to have your South Texas witness play the roles of Charlie Bingham (plaintiffs' expert) and Claire Alastor (defendant) while team members play the roles of Cameron Tucker (plaintiff) and Leslie Collins (defendant).
- (3) to have your South Texas witness play the roles of Cameron Tucker (plaintiff) and Leslie Collins (defendant) while team members play the roles of Charlie Bingham (plaintiffs' expert) and Claire Alastor (defendant).

Teams must indicate their choice by Monday, March 11th by sending an email to mocktrialchallenge@stcl.edu.

If you have not already done so, please make your hotel reservations at the Four Seasons. Even though the deadline has passed, I understand there is still space available. Let me know if you have any trouble making reservations.
