- You may NOT receive compensation for your externship work and may NOT receive credit for work performed at a profit-making entity (law firm, corporation, etc.). See Dean Dennis for alternatives.
- For each credit hour, you are required to work 60 hours at your externship placement.
- Your externship work may begin one week prior to the beginning of the semester for which you are enrolled.
- In order to receive credit, student journals and time sheets must be filed weekly, contemporaneously with your work. **NO** credit will be given for work done in a prior semester without prior written approval from Dean Dennis.
- Students must work a minimum of 10 weeks at their externship placement during the fall and spring semesters. During the summer semester, students must work a minimum of 6 weeks at their placement.
- Additional requirements will be discussed at that **first** seminar meeting of the semester. **Attendance is mandatory.** No Absences are allowed.
- I agree to abide by these rules and understand that the information I provide will be verified by the Registrar before classes begin, and that if I do not qualify, I will be dropped and my place offered to an eligible student.
- I confirm that I have researched the mission, policies and procedures of my placement and understand what will be required of me.
