³Requires a Supervised Research Form signed by supervising full time faculty and submitted to the Registrar's Office along with an explanation of proposed research and enrollment in research for approval and enrollment in the course. You must have completed 45 s/hrs or more with cumulative gpa of 3.000 minimum - no exceptions.
