The tournament problem has been released.

One of the things you will notice about the problem is that two depositions have not been included. For those of you who have always wished to add a fact to make a problem more balanced, here is your chance. One witness (Sebastien Raine) will be added for the plaintiff. One witness (Ray Buttani) will be added for the defense. Each may testify by deposition. I will take suggestions for what these additional witnesses should be as well as the specifics of their testimony. Also, I will entertain suggestions for any other substantive modifications to make the problem more balanced. You have to try both sides of the problem so you have an interest in having an even playing field. Just send me an email by the deadline for clarifications. I don't promise I will include every suggestion but I will consider all submissions.

While teams are given significant latitude in choosing which witnesses to call live, the problem requires certain to be played as males and certain to be played as females. Twyla Sands and Moira Rose must be played as females. Johnny Rose and Ted Mullens must be played as males. The other witnesses (Shannon Gibbs, Stevie Budd, Pat Brewer, and Ronnie Lee) may be played as males or females.

This year's trial brief topic is a response to a motion to dismiss. For purposes of the trial brief only, teams are to assume that Moira and Johnny Rose have not settled and have filed a motion to dismiss based on the fact that they have a constitutional right to choose not to vaccinate their child and that state law allows a personal-belief exemption. In essence, they argue that they cannot be liable in tort if state law permits them to opt out of the mandatory vaccination requirements. You represent the Plaintiffs and must file a response to the motion to dismiss. Remarkably, South Texas has adopted the same rules as the Federal Rules of Civil Procedure. (e.g., cite as So. Tex. R. Civ. P. 12(b)). Look to the Local Rules for the specific requirements of the trial brief.

If you haven' already done so, please make your hotel reservations. Instructions are attached.
