Several updates for a Friday afternoon.

1. Harris County is offering free health care for those affected by coronavirus. I mentioned this in Update #4 (way back on March 12), but it may be more urgent for some now than it was then. 3. Please see the attached Q&A regarding how the law school will implement the Credit / No Credit Grading Policy for this semester. Thank you to everyone who reached out to me this week with questions; the faculty and I have tried to address all of them here. Your questions and your suggestions were invaluable in shaping this final document, and you will find many of your recommendations included.

As I mentioned last week, there are very few easy answers this semester, and the information available to us is constantly evolving. We know -- and regret -- that no approach will satisfy everyone. Throughout this spring, we have been guided by the principles of fairness, opportunity, diversity, community, excellence, and justice that make South Texas strong. And, none of these decisions is taken -- or made -- lightly. For instance, several faculty members and I spent many hours over the past week drafting the procedures that will implement the Grading Policy. Another group of faculty spent several hours drafting procedures for final exams. That led to the creation of the attached Q&A and another Q&A relating to Final Exams (see item 4, below). Then, the entire faculty met for another 2 1/2 hours (at our now-weekly faculty meeting) this morning finalizing everything.

I continue to thank you for your patience and your understanding as we all work through these issues.

## 4. We are finalizing the Q&A answering all of the questions we have received regarding Final Exams, which will be forwarded to everyone by Monday.

5. I will hold a Community Zoom gathering next week. Now that we have upgraded to the site license for Zoom, I have a new resource: the ability to host a large community gathering! I have been wanting to do this, and now we can test it out. Watch for more details!

## 7. Several notes for next week:

- We will circulate information regarding the CARES Act -- and the opportunities it offers for students who have student loans.
- We will send an update on financial aid and other opportunities for students who find themselves with unexpected financial emergencies.
- We will provide updates on the steps that South Texas is taking to assist students with internships, externships, clerkships, and employment.
- We will provide more information on new summer course offerings and registration. (Our plan is that summer courses will be offered on campus, assuming health and safety, and city and state ordinances, permit it.)

That hope, however, also gives us power over our lives and our situation. While things may be disrupted now, we will -- soon enough -- be back on campus and resuming our daily activities. I can't say exactly when. But, I live in hope. I am confident that our South Texas community, together, will persevere!
