2. The great team in the Library has devised a means to help those who need some printing done. Here are the instructions they asked me to forward:

We understand the needs of some students to print material for their classes. While we cannot open the building to anyone but essential employees under the stay at home order, the Library staff will provide a pilot service for student printing next week. At the end of next week, the Library staff will evaluate if the process listed below needs adjusting. We anticipate providing this service each week through May 12th.

- Please rename all of your files to start with your last/first name so the Library staff can sort them, e.g. ParksFred ConLaw outline.
- Send print requests (attached files) to askpat@stcl.edu by noon on Tuesday, April 21st.
 - You may request up to a total of 200 images (printed sides).
 - All printouts will be double sided (i.e. printed on each side).

- In the event that there is a problem printing your file, we recommend including a phone number in your email to askpat@stcl.edu so you may be contacted.
- You will be emailed once your printouts are complete. You should NOT come to campus on Friday until you receive that email.
- Printouts can be picked up on Friday, April 24th between 1:00pm and 3:00pm at the Faculty/Staff entrance on the Polk Street side of the Campus.
 - A Library staff member (with proper protection) will be curbside to 'hand' you your materials.
 - You will be required to show your ID, but you will not need to exit your vehicle.

In the event that demand is higher than we anticipate, you will be contacted on Tuesday April 21st and another pick-up time will be scheduled. If you have questions about this process, please email askpat@stcl.edu.
