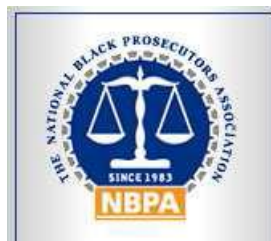
The DuPont Legal Minority Job Fair is held every summer. More than 30 law firms and legal service companies that work with DuPont will interview selected law school students.
