A couple more clarifications:

- The information contained on the documents connected to the hyperlinks in Exhibit O are not considered part of Exhibit O itself. You may not rely or introduce these hyperlinked documents.
- Plaintiffs may offer any or all of the deposition testimony of the persons described in paragraphs 8, 10, and 11 of the Pretrial Conference Report. Defense may offer any or all of the deposition testimony of the persons described in paragraphs 9 and 12 of the Pretrial Conference Report. Teams may introduce whatever deposition testimony they wish. Teams may offer depositions in their entirety or by making specific designations. They may even do so constructively to save time or, if they wish, do so by reading specific questions and answers. See Local Rule 5.003.
- Team members may choose to be separated or compete in the same room.

• Team members may choose to sit or stand while competing.
