Visiting and Audit Status

2011-2012 Academic Year and 2012 Summer Session

During the academic year, tuition is set depending on your status as a full-time or part-time student; during the summer session tuition is determined based on the number of hours taken. The full payment of tuition and fees is due by the published due date unless the deferred tuition payment option is utilized. Details of this program are described below:

DEFERRED TUITION PAYMENT OPTION

1. The deferred payment option is available **ONLY** at registration.
2. 50% of tuition and a \$300 mandatory **NON-REFUNDABLE** Registration and General Services Fee must be paid by the published due dates. Financial Aid recipients will be deemed to have met this requirement if they have **accepted** aid in the form of Stafford Loans, TEG, or institutional scholarships in amounts sufficient to meet the above requirements. Grad Plus loans do not qualify for this provision. **Any shortfall must be paid in full.**
3. **No bills will be sent prior to the payment deadline.** You may access your account information online via STANLEY. **(SEE THE TUITION AND FEES AND THE DEFERRED PAYMENTS SCHEDULES FOR REQUIRED PAYMENT AMOUNTS AND DUE DATES.)**
4. Failure to make the required payments will result in the denial of this payment option for any future enrollment period. In addition, failure to make the required payments may result in exclusion from classes and will result in a hold being placed on your account until payment is received. Payments made by check or e-check are subject to a 10 day waiting period before a hold will be released. To have a hold immediately released, payment must be in the form of cash, cashier's check or money order.

NOTE 1: Students must be enrolled in at least 6 credit hours during the fall and spring semesters and at least 3 credit hours in the 8-week summer session to be eligible for financial aid.

NOTE 2: If your Financial Aid does not fully cover your tuition and fees, you must, at the time your financial aid is disbursed, pay the shortfall in full or your account will be subject to the deferred payment deadline with respect to the shortfall.

\$25.00 WILL BE CHARGED FOR EACH RETURNED CHECK. IF A CHECK GIVEN TO SOUTH TEXAS FOR REGISTRATION IS RETURNED FOR ANY REASON, OTHER THAN STOP PAYMENT, REGISTRATION WILL BE CANCELLED. The student may then register for any open classes during late registration and be subject to the \$40.00 late registration fee.
