## TUITION/FEE SCHEDULE

### 2022-2023 Academic Year and 2023 Summer Session

During the academic year, tuition is set depending on your status as a full-time or part-time student; during the summer session tuition is determined based on the number of hours taken. The full payment of tuition and fees is due by the published due date unless the deferred tuition payment option is utilized. Details of this program are described below:

#### DEFERRED TUITION PAYMENT OPTION

1. 50% of tuition and a \$350 mandatory **NON-REFUNDABLE** Registration and General Services Fee must be paid by the published due dates. Financial Aid recipients will be deemed to have met this requirement if they have **accepted** aid in the form of Unsubsidized Loans, approved Graduate Plus Loans, TEG, or institutional scholarships in amounts sufficient to meet the above requirements. **Any shortfall must be paid in full.** To determine if you are ineligible for this option, select View Holds from the Student Account Menu.
2. **The college does not provide invoices.** You may access your account information online via STANLEY. **(SEE THE TUITION AND FEES AND THE DEFERRED PAYMENTS SCHEDULES FOR REQUIRED PAYMENT AMOUNTS AND DUE DATES.)**
3. Failure to make the required payments will result in the denial of this payment option for any future enrollment period. In addition, failure to make the required payments may result in exclusion from classes and will result in a hold being placed on your account until payment is received. Payments made by check or e-check are subject to a 10 day waiting period before a hold will be released. To have a hold immediately released, payment must be in the form of cash, cashier's check or money order.

**NOTE 1:** Students must be enrolled in at least 6 credit hours during the fall and spring semesters and at least 3 credit hours in the 8-week summer session to be eligible for financial aid. The amount of qualified aid you have accepted is located on the Account Detail for Term page on the Student Account Menu.

**NOTE 2:** In addition, all prior balances must be paid by the published due date.

**A \$25.00 FEE WILL BE CHARGED FOR EACH RETURNED CHECK. IF A CHECK GIVEN TO SOUTH TEXAS FOR REGISTRATION IS RETURNED FOR ANY REASON, OTHER THAN STOP PAYMENT, REGISTRATION WILL BE CANCELLED.**
